A Canberra Hospital Master Plan is being developed to guide the future physical development of the ACT's largest and busiest hospital.


The Master Plan will **guide the development of the campus over the next 20 years** and provide a planning framework about how the campus can change into the future to best support our growing and changing population.

The Master Plan will ensure future changes **make the campus welcoming and usable** for patients and staff.





CANBERRA HOSPITAL MASTER PLAN planning process



Phase 1 participation

- twelve community pop-up events
- seven Community Council events
- more than 465 participants across the events
- direct feedback via email and stakeholder meetings from 31 individuals and groups
- we heard from over 530 individuals and representative groups in total
- more than 890 pieces of feedback from community and stakeholder groups
- more than 4520 views of YourSay content
- 2800 households received our flyer in a letterbox drop
- near neighbours to the hospital received door knock visits.
