- First site is presently RSPCA. Negotiations underway to move RSPCA.
- Other site is *Coolo Park* site which is in the Master Plan and has always been the plan since 2014.

Q: What are the principles of the tender for the land release sites and the private sector? A: MP once it is bought it will be their property

Concerns raised about the lack of consultation and the transition to new planning legislation which may have negative planning and development impacts on the Weston Creek community.

Q: Re-routing C5 runs up towards Cotter Road. There is a for future development sign near present path. Is there consideration for re-routing, taking into account old AFP site? What will happen to that land?

Q: Do you know why Minister Gentleman has not replied to WCCC letter? A: No
