## Sample questions and comments from the audience:

- What types of Government assistance can you get? A: Government is keen to engage community, example given of the archery group tree planting assistance
- Clarity of catchment areas: Molonglo and Forest Park are covered by Molonglo Catchment Group and Molonglo Conservation Group
- Who covers the areas behind the carpark behind the RSPCA? Worried about run off and rubbish. A: Molonglo.
- Observation of foxes in the area.
- Environmental issues include rabbits and invasive weeds.
- Can the group help small groups for example neighbourhood parks? A: Yes, have supported individuals. However, government only helps larger groups
- What are the first steps for groups? A: Depends on site. Member will meet group on site looking at traffic on and ecology of area, access, to assess the landscape. Can help with a letterbox drop. Planting gains interest but there will be a lot of weeding.
