# MINUTES PUBLIC MEETING. WEDNESDAY, 27 SEPTEMBER 2023

#### **ACKNOWLEDGEMENT OF COUNTRY**

We are honoured to be meeting on the ancestral lands of Aboriginal and Torres Strait Islander people. We acknowledge these First Australians as the traditional custodians of this land, whose cultures are among the oldest living in human history. We pay respect to the Elders of the communities in the Murrumbidgee region and extend our recognition to their descendants – past, present, and future.

GUESTS: Major Projects Canberra Team officials to talk about Light Rail design. See also Powerpoint.

# PRESENTATION:

- Overview of light rail stage 2A to Woden and the raising of London Circuit.
- Early utility works are close to being completed, about a week and a half.
- There is a temporary sidetrack on the western sidetrack of Commonwealth Avenue. Demolition of the south bound bridge is underway, and fill will be added.
- Completion date early next year.
- The next small step of the project is the green track for light rail stage 2A. There will be plantings and turf. Completion hopefully Christmas and then on display for 12 months as a prototype.
- The existing depot at Mitchell is being expanded. This will house 5 new vehicles fitted with CESS. The depot will provide space to retrofit the existing LRVs.
- Update on Stage 2A, Completion 2027:
  - o works approval and development approval has been granted.
  - o There will be a stop on Canberra Avenue. There will be a terminus at Commonwealth Park.
  - North of Lake Burley Griffin, there will be temporary traffic management at Parkes Way due to construction.

### **QUESTIONS AND COMMENTS:**

- Q: Would be better if you could see the works, rather than it being behind shade cloth. A: There will be opportunities. It is also to reduce dust.
- Q: When will the current works be completed? A: Stage 2B A; end of 2024. Intention then new contractor will break ground 2025, taking to end of 2027.
- Q: There is a Disruption Task force, how is this going for drivers, pedestrians and cyclists? A: Temporary traffic proposals gets presented and endorsed at a forum (including this team and TCCS) before approval.

- Concerns:
  - o Access to light rail stations and complying with Disability Standards is an issue. Trip hazards.
  - There is also interest in the Deakin area and getting to health services.
  - o Needs to go all around London Circuit, to the airport, and the hospital.
  - Poor access to institutions is an equity issue.
  - Consideration needs to be given to closer stops or shuttle buses to connect to various venues.
  - Need to see the whole plan.
- Stage 2B consultation will be next year.
- Q: If the Police Station moves, will the right hand turns change? A: General movement will be left turn. Right turn only under lights in an emergency.
- Q: Why raising London Circuit and not over City Hill? A: Heritage area. Also, for activating the area, employment growth and businesses.
